Soil/Soilless/Hydroponics: 1/2 to 2 tsp per gal.

Compost Tea:  $\frac{1}{8}$  to 2 tsp per gal. Foliar Sprays:  $\frac{1}{8}$  to  $\frac{1}{2}$  tsp per gal.

### Field Application:

Soil Fertility: 3 to 12 lbs per acre.
Soil Mixing: 1 to 2 lbs per cubic yard.

Lawn and Garden: 2 to 4 oz per 1000 sq ft.
