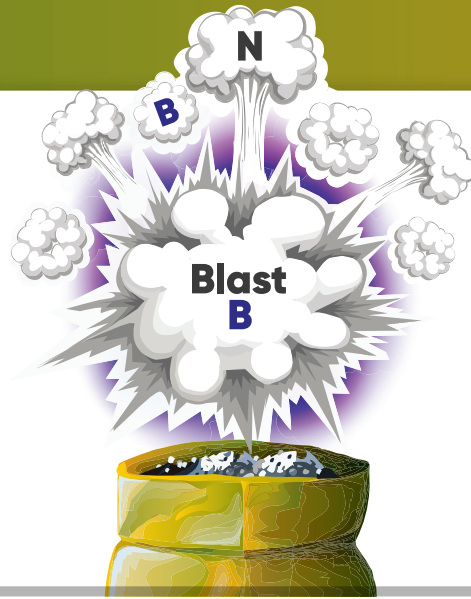

**Greenhouse & Indoor Production:**

Soil/Soilless/Hydroponics/Compost Tea/Foliar Sprays (per application as needed) ¼ to 1 tsp per gal.

**Field Application:**

Soil Fertility/Foliar Application – 1 to 2 lbs per acre.

**Lawn and Garden:** ¼ to 1 tsp per gal.

1 tsp = ½ tbsps = 0.1 oz = 3 grams.

**GENERAL INFO:** This product can be applied to all crops including

trees, vines, ornamentals, small fruits, vegetable, row crops, field crops, feed crops, forage and pasture. It can be applied by broadcasting, in-furrow, as a side dress, via spray and through fertigation. Consult with your agronomist for application recommendations. Perform a jar test prior to tank mixing. While applying this product, consider reducing overall fertilizer application rates.
