DIRECTIONS FOR USE

Small Garden, Vegetables: Apply 1 lbs. along the bottom of a 24-foot section of the seed furrow, followed by a layer of soil before seeding. For hill plants, place one cup in the bottom and sides of the planting hole, followed by a layer of soil. For legumes, use one cup every 50 feet as less nitrogen is required. During the growing season, apply an additional 1 lbs. every 50 feet after your blooming, and work in. Always water in newly applied fertilizer.

Field Vegetables & Orchard Applications

Broadcast: Apply up to 1,000 lbs./ac using conventional spreading equipment, product is most efficient if tilled immediately after application.

Side Banding: Apply 500 lbs. per acre in most soils.

For broccoli and Romaine rate can be increased to 600 lbs. per acre.

Hand Application: Apply up to 250 lbs. per acre

Wheat: Apply 250 to 500 lbs. per acre during seeding.

Rice: Follow above directions, allowing at least two weeks before flooding field.

New Orchards: Place ½ lbs. of product in the bottom of the planting hole, cover with at least one inch of dirt before planting.

Revitalization of Old Orchards: Drill a 2" hole approximately 12" deep at 18"-24" from the trunk. Fill to the top with fertilizer.

Application Rates: Most crop lands require two applications, one in the spring and one in the fall. High nitrogen crops may require up to three applications during the primary growing season.

STORAGE & DISPOSAL: Do not contaminate water, food or feed by storage or disposal. Store in original container tightly sealed in a dry location. Dispose of packaging according to state and local authorities.
